THAT the property platted herewith is subject to and a part of a Property Owners Association comprised of all lot owners within the CRESTONE development and that Common Area F as shown on the Plat of CRESTONE RIDGE II are Common Areas to be owned and maintained by said Property Owners Association. 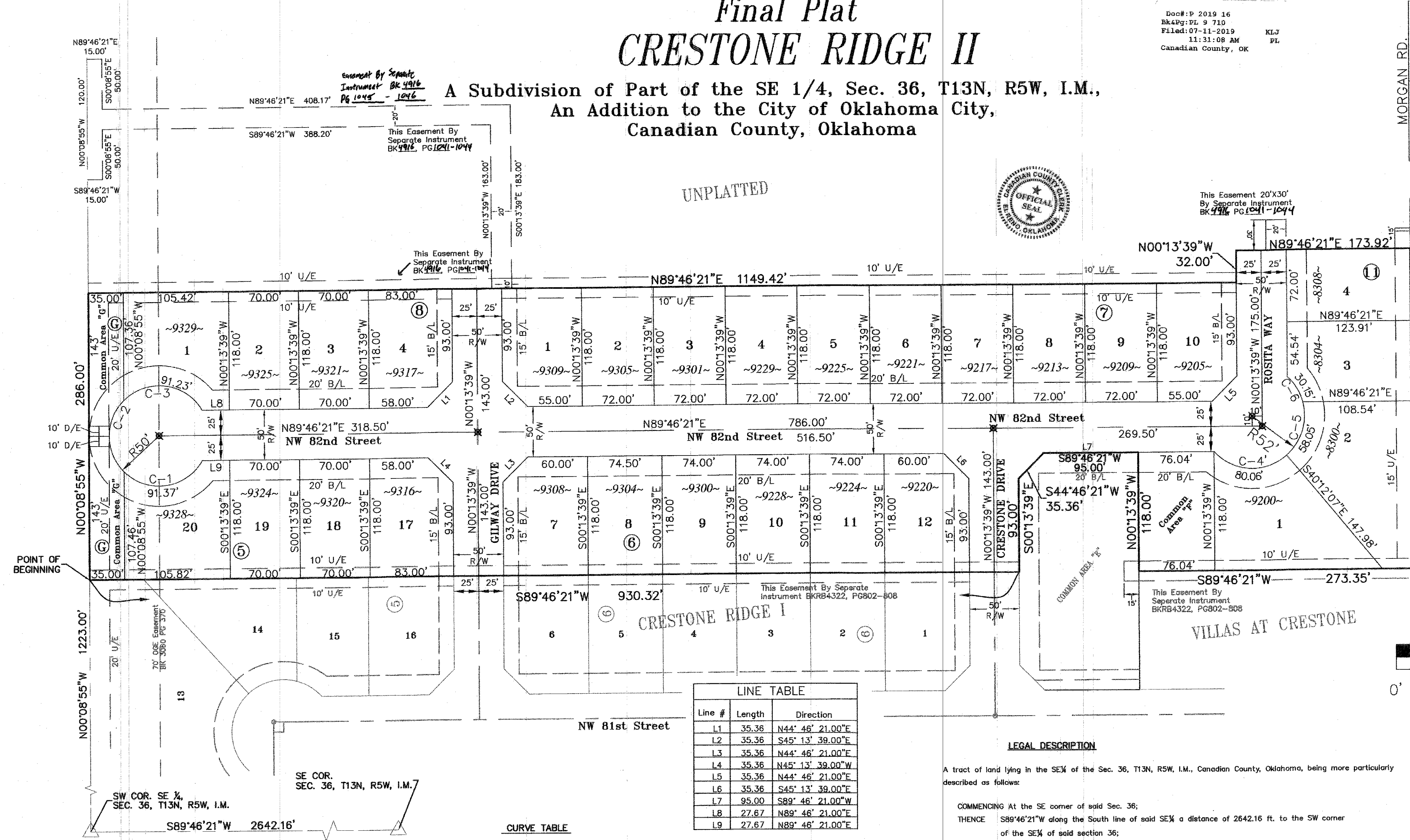

NOTES:

- The property owners within this plat and/or the property owners association of CRESTONE Ridge Addition shall share in the responsibility of maintenance of islands/medians within street rights-of-way, landscaping along Wilshire Boulevard, and the common areas platted and developed in all phases of the CRESTONE Ridge Additions. No Structures, storage of material, grading, fill or other obstructions, either temporary or permanent, shall be placed within drainage related common areas and/or drainage easements. Certain amenities such as, but not limited to, walks, benches, piers and docks shall be permitted if installed in a manner to meet the requirements specified above.
- A sidewalk shall be required on each lot where it abuts a local and/or collector street. The sidewalk is required at the building permit stage and must be installed prior to the issuance of a certificate of occupancy for the applicable lot.
- Either one 3-inch caliper deciduous tree or two 1 1/2-inch caliper deciduous trees shall be planted in the front yard of all lots where the garage extends beyond the front wall of a residence, towards the street right-of-way.

SURVEY NOTES:
